On March 13th, COVID-19 stopped everybody in their tracks. But local nonprofits, which faced a dramatic and immediate escalation of client needs, had to keep going.

Because this crisis was unlike any they'd ever experienced, local nonprofits knew they had to be nimble. They had the confidence to react quickly to the crisis because they knew they had the support of their United Way. And so, like Jack in the age-old nursery rhyme, they leapt into action to assist every sector of our community with food, shelter, COVID-19 testing, education, childcare, and more.

Kennett Area Community Service (KACS) is the frontline of emergencies in our community.

Being responsive to an overwhelming spike in need is one thing. Providing relief for the increased numbers safely and effectively over many months is quite another. KACS moved its food distribution outside, found alternative locations for food collection, and facilitated COVID-19 testing.


Since March, they have had more than 16,500 visits for food and continue to receive 70–100 requests for housing assistance every week. UWSCC provided more than \$165,000 to help KACS meet these needs.

In Oxford, The Lighthouse Youth Center also established a food collection and distribution site.

As the community's needs grew, they found they needed a commercial refrigerator to accept and distribute milk, fresh fruits and vegetables, and other perishables. UWSCC, always just a phone call away for our local nonprofit agencies, bought that refrigerator for them.

Because seniors are among the most vulnerable to the virus, the Kennett Area Senior Center had to close its doors in March, pressing pause on the programs UWSCC was funding.

But UWSCC reached out to discuss a possible reallocation of funds to support seniors in our community, many of whom have been isolated and unsure where to turn for help. UWSCC was able to reallocate funds to support an expansion of the Center's Information and Referral program, which continues to provide an invaluable lifeline for seniors via phonecalls.

Tick Tock Early Learning Center was one of the first childcare facilities to reopen in June to care for essential service workers' children.

They rapidly implemented new safety procedures and protocols for children and staff. Steps included mask-wearing, daily deep cleaning, tons of personal protection equipment, and increased staffing. UWSCC was there for them also, providing \$87,180 in funding over the past year.

In March, The Garage Community and Youth Center began a drive for essential items to distribute to local families in need.

They welcomed Mighty Writers into their West Grove facility to distribute food and supplies there. In September, they established “learning pods”—safely distanced and Wi-Fi-equipped spaces where students receive support as they navigate the challenges of online instruction. UWSCC funds both Garages with \$100,000 to help their efforts.

Closing the doors was not an option for La Comunidad Hispana (LCH), which provides essential medical services for low-income and uninsured people.

LCH quickly established a safe COVID-testing site in tents outside their Kennett Square facility. UWSCC sourced \$75,000, so LCH could take testing to mushroom farms to help prevent the spread of COVID-19. Another \$132,560 from UWSCC over the year enabled LCH to continue case management and dental services.

These nonprofits had to focus on safely meeting unprecedented needs. None of them had the extra bandwidth necessary to raise the kinds of funds needed to meet these unexpected costs. But UWSCC was there for all of them—raising funds for COVID-19 needs and continuing to provide agency support. Perhaps more than at any other time in our 75-year history, it's impossible to imagine where our community would be today without UWSCC.

The trusted and steady presence of UWSCC in the community means nonprofit agencies can turn to us for support, advice, and connections. And donors can count on us to know where dollars are needed the most.
